

MILITARY AUTOSOURCE 2019 FORD OPERATION HOMEWARD BOUND OFFICIAL RULES AND REGULATIONS

No purchase necessary to enter The 2019 Ford Operation Homeward Bound Contest (The Contest). Purchase does not improve your chances of winning.

1. **ELIGIBILITY:** The Contest is open to U.S. Military Personnel and Attached Civilians, 18 years or older with a valid driver's license, who are authorized by the Exchange/NEXCOM to purchase through the military exchange system and who are stationed or deployed OCONUS during The Contest period.

2. **PROMOTION PERIOD:** Contest begins June 7, 2019 and ends July 31, 2019. Entries must be received by Wednesday, July 31, 2019.

3. **HOW TO ENTER:** Limit of one entry per person for The Contest. Participants must visit the contest entry page militaryautosource.com/homewardbound. On this entry page participants can select from two ways to enter the contest. The first entry method is to submit a short story 300-500 words and second entry method is to submit a short, one to two-minute video. For each entry method participants should tell us why they, a military family member or friend deserve to win roundtrip airfare home. All entries must be filled out completely and accurately with first and last name, daytime telephone number (including area code/country code), and email address. Any form of entry other than that described above is void. Online entrants must have a valid email address in order to enter. All entries must be received and recorded during the Promotion Period to be eligible for the contest. Employees and families of Military AutoSource and its affiliates, the Exchange/NEXCOM, Ships Stores and its affiliates and subsidiaries are not eligible. Void where prohibited by law. All federal, state and local laws and regulations apply.

4. **ENTRANT'S PERSONAL INFORMATION:** If you are selected as a winner, your information may also be included in a publicly-available winner's list.

5. **FINALIST DRAWING:** Three finalists for each entry method (short story and video) will be selected from all eligible entries received by the close of business on July 31, 2019. The 6 finalist entries will be selected based on what MAS considers to be the most compelling stories. Military AutoSource will contact the finalists by phone or email. In the event MAS cannot locate any of the finalists within ten (10) days of date of attempted notification, the individual's finalist status may be forfeited and an alternate finalist chosen. Military AutoSource will then conduct meet and greet interviews either in person or over the phone with each of the six finalists to verify eligibility. At the conclusion of these interviews, to be completed by August 23, 2019, two Grand Prize winners will be selected: One for the short story contest and one for the video contest.

6. **GRAND PRIZE WINNER NOTIFICATION/REQUIREMENTS:** The two grand prize winners will be contacted by phone or email by Military AutoSource. MAS and its agencies assume no responsibility or liability for any damages, losses, or injury resulting from the acceptance or use of any prize. In the event MAS cannot locate the winner within ten (10) days of date of attempted notification, the prize may be forfeited and an alternate winner chosen. Potential winners shall be required to complete, sign and return to MAS an Affidavit of Eligibility and a Liability/Publicity Release (unless otherwise prohibited) within ten (10) days of date of attempted notification. If a winner cannot be contacted within ten (10) days, fails to complete, sign and return the Affidavit of Eligibility and Liability/Publicity Release within the required time period, is not in compliance with these Official Rules, or a prize or prize notification is returned as undeliverable, prize may be forfeited. MAS is not responsible for any change of email address, mailing address and/or telephone number of entrants.

MAS reserves the right at its sole discretion, to disqualify any individual (who tampers with the entry process. Entrants may not register with multiple email addresses nor may entrants use any other device or artifice to register multiple times or as multiple registrants.
